## The County Society & the Organization Movement 100 Years Ago

*The recognition of the importance of the county society as a unit is the basic principle on which the work of organization has been and is being conducted. The most important unit in the scheme of organization is the county society; then come the state association, and the American Medical Association. The last is the least important of the three; the first – the county society – the most important. Every effort that has been made by the American Medical Association in developing organization has been made with the above principle in view – the importance of the county or local society.*

*Now the machinery all over the country is practically complete, and results must be looked for. These are many, but the most important is that of making the county society something more than a name – something more than a piece of machinery lying idle, rusting: it must be made a living force to dignify medicine as a profession, to increase public respect for, and to elevate the material, moral and intellectual status of that profession.*
